20th Photography Contest of Corrosion and Materials Degradation

Regulation

1 - PURPOSE

The 20th Photography Contest of Corrosion and Materials Degradation organized by ABRACO - Brazilian Association of Corrosion and on the occasion of INTERCORR 2016, has the aim to encourage the disclosure of characteristics and visual aspects (morphology) of the various types of corrosion with learning objectives.

2 - PARTICIPANTS

- 2.1. All attendees enrolled in INTERCORR 2016 can be part of the contest.
- 2.2. Each participant may apply to the contest with only ONE photograph.
- 2.3. The contest only allows photographs of the attendees who are duly enrolled in INTERCORR.

3 - THEMES

All aspects of corrosion in parts and equipment.

4 - PRESENTATION

- 4.1. Photographies in black and white and colored shall be accepted.
- 4.2. Each participant can apply one photography.
- 4.3. Photographies must be sent in JPG format, with resolution of 200 dpi and up to 2Mb size. Photographies without this format shall not be accepted.
- 4.4. Photographies with Photoshop treatment and/or highlighting details shall not be accepted.
- 4.5. None photography shall have any marks or information which might identify its author(s) and/or company(ies).
- 4.6. Only technical descriptions shall be accepted, not exceeding 300 characters.

5 - ENROLLMENT PERIOD

All photos must be sent until April 16, 2016.

6 - EVALUATION PROCEDURE

- 6.1 Photographs sent to the contest are previously evaluated by the Technical-Scientific Committee as for thematic relevance of the Congress.
- 6.2 All participants of the INTERCORR 2016 will be able to vote in the photography of their choice. Voting will be closed at 10 am on May 20 and counting of votes will be by electronic counting performed at 10h30 am on the same day.
- 6.3 The disclosure of the Contest's winners and the delivery of awards will be carried out during the Closing Ceremony of the event.

7 - AWARD

- 7.1. Only the authors of the photographies classified in first, second and third shall be awarded, with one prize per classification.
- 7.2. In case of an awarded photography has more then one author, only one prize will be given and the its division is at the exclusive discretion of the authors. ABRACO has no liability for the destination of the prize.
- 7.3. In case of draw, a raffle will be done in order to establish the rankings.

8 - EXHIBITION

All material submitted will be exhibited during the INTERCORR 2016.

9 - GENERAL CONDITIONS

- 9.1. All material from the Contest, regardless of award, will be included in the ABRACO archives. Thus, ABRACO may disclose the photos at its discretion and without notice to the author(s).
- 9.2. The material that not comply with this Regulation shall be automatically disqualified for awarding of prizes, however, it can be part of the exhibition or of the technical archive of ABRACO.
- 9.3. All cases not covered herein shall be discussed by the Executive Committee of INTERCORR 2016.
- 9.4. Any form of disclosure of a photography by its author is prohibited, as well as any requests for vote.
- 9.4.1 The noncompliance of this regulation will result in the disqualification of the photography.

10 - ENROLLMENT

The confirmation of the enrollment in the 20th Photography Contest will imply in the full acceptance of this Regulation, reserving to ABRACO the disclosure rights of the material submitted.
